Director ITS Engineering College, Member Secretary, welcomed the Hon'ble Chairman and Members to the 17th Governing Board & Advisory Council meeting.

The Chairman then declared the meeting open for discussion and asked the Director to initiate the proceeding of the meeting. The 'Agenda' for the meeting along with the 'Action taken Report' on the previous meeting were circulated in advance and were also placed on the table.

i) **AGENDA ITEM NO. 1:**

Confirmation of the Minutes of the Last Meeting:

As per Agenda Item No. 1, the Director requested the members to approve the Minutes of the last meeting of the Governing Board & Advisory Council held on 20th December 2020.

After Some discussion on the Minutes and also on the 'Action taken Report', the minutes of the previous meeting were unanimously approved.

ii) **AGENDA ITEM NO. 2:**

To appraise the members about the progress made since the last meeting:

The Director ITS Engineering College made a detailed presentation covering progress made since last meeting on the following salient points:

- Academic results
- Faculty Strength
- Departmental & College Publications
- Guest Lectures, Conferences, Seminars, FDPs and Workshops organized
- Placement details of last academic session & progress of current academic session.
- NBA & NAAC Accreditation Progress made so far.
- Entrepreneurial Initiative.
- Co-curricular and Extra-Curricular Events.
- Work for Social Cause & Forthcoming Initiatives.

The achievements were appreciated, and the members expressed their satisfaction with the Academic Progress and Academic initiatives taken since the last meeting.

iii) **AGENDA ITEM NO. 3:**

Ratification of Faculty Appointments:

Twelve faculty members were appointed after the last meeting list of faculties is enclosed as Annexure-1. The qualification, experiences, and merit of each faculty were discussed and the appointments were unanimously ratified by the members.

iv) **AGENDA ITEM NO. 4:**

Placement Activities:

The details of the various placement activities for the entire period were appraised by the Director in his presentation. The efforts of placement were appreciated by all the Members.

v) **AGENDA ITEM NO. 5:**

Inviting suggestions on enrollment improvements.

The subject was discussed and the following initiatives were communicated to the members:-

- **Utilization of outdoor and print media** both at the national and local level to promote all ongoing activities and achievements in the institute.
- **Placement achievements of students** identifying and highlighting the same.
- **Showcasing faculty members' achievements** at various forums including corporate, academic, and social media platforms.
- **Promoting innovative idea generation by organizing Hackathons and increasing numbers of sponsored projects** and showcasing these activities and student work to the outside world.
- **Interaction with the parents/guardians** accompanying the students on the day of orientation and also giving them a broad overview through a PPT presentation about the institute. Interaction with parents is also maintained through phone calls by counselors about student progress and through parent-teacher meetings (PTM).
- **Gym and in-house sports facility within Girls and Boys Hostels** for all students in the institute to make their stay more comfortable and enjoyable.
- **Regular inter-college local and state-level sports events** are being conducted for the students to give them exposure to activities and inculcate in them a feeling of healthy competition and team spirit which is of paramount importance for the growth of students in any institute.
- **Organizing Yoga sessions under the fit India Movement** to create awareness about yoga amongst students which will make them healthy and happy individuals.

- **Renovation of the canteen** - The hangout café (the existing canteen) has been renovated with all the modern aesthetics and amenities for the comfort of students.

vi) **AGENDA ITEM NO. 6**

Review of Academic Results:

A detailed review of last year Academic Result was done during the meeting.

The Members appreciated the progress made on the Academic Result and conveyed their full satisfaction on the initiative being taken by the college through new pedagogical concepts being adopted by the faculty resulting much improve results from last time.

vii) **AGENDA ITEM NO. 7:**

Discussion on the progress of NBA & NAAC Accreditation:

The Director briefed the members that the college is going for the renewal of NBA Accreditation of ECE branch. The NBA accreditation of ECE is going to be expired in July 2022. Hence, Department is instructed to apply for reaccreditation within the stipulated time. He also briefed the members that CSE branch has also started preparation for the NBA Accreditation.

The Director also briefed that the submission of NAAC SSR is pending for cycle 2. Although the fee submission and approval of IIQA had been received in September 2020, due to lockdown, the process of SSR submission is not completed yet.

The members raised their concern for fast action to complete the accreditation process of NBA and NAAC.

viii) **AGENDA ITEM NO. 8:**

Review of initiative by the college in Innovation, Incubation and Entrepreneurship

The Director briefed the members about the progress in a detailed manner which is attached in the Director's presentation.

NewGen IEDC: The Director briefed the members about the NewGen IEDC innovative project development status and apprised them that 16 selected projects for second year i.e. 2020-21, and have been completed within the defined timelines till June 2021. The utilization for the funds to NewGen IEDC has already submitted to the DST for session 2020-21.

For session 2021-22, 20 projects have been selected. However, the grant for the session 2021-22 has not been released by DST till now, although, the work on the projects is in progress with institute support. The selection for the third year NewGen IEDC project is in process and would be presented in upcoming advisory board meeting of NewGen IEDC.

Since the last meeting 5 Patents were published and 1 patent was filled.

IIC Ranking: For the session 2019-20 the institute received five star rating in IIC Ranking by Ministry of Education. However the IIC rating for session 2020-21 is yet to be declared.

ARIIA Ranking:

Certificate of Appreciation in 2020 ARIIA Ranking the institute got recognition in the Band Institution (6 to 25) in the category of Private/self Finance Colleges/ institutes. The ARIIA ranking for the session 2021 is yet to be declared.

ix) **AGENDA ITEM NO. 9 :**

Review of Offline classes and readiness of Labs/ Centre of excellence on account of normalization of pandemic situation Subject was discussed and the board members were apprised of the progress of offline classes. The members raised their concerned to review the status of the available infrastructure facility for teaching learning. All the equipments and other facilities should be in full working condition and where ever the up-gradation due to change in technological advancements is required at different department labs should be incorporated.

x) **AGENDA ITEM NO. 10 :**

Discussion on the strengthening of industrial collaborations:

The subject was discussed and updates were communicated to the board members. The Director briefed the members that the college is planning to revive the faculty industrial connect with the normalization of the pandemic situation. All departments are advised to connect with the reputed local industries for faculty training, expert talks, industrial visits, and student internships.

xi) **AGENDA ITEM NO. 11 :**

Implementation of New ERP - The Director informed all the members that the new ERP procured "Qualcampus" is in the process of implementation. The student attendance is already being uploaded on the ERP. The initial modules such as Feedback, Examination, Library and Hostel modules are yet to be implemented.

The members raised their concerned about slow implementation of the new ERP. They suggested that the concerned persons responsible for implementation of different modules of ERP should be instructed for fast action at their end. Proper implementation of ERP is required for the normal functioning in an institute.

xii) **AGENDA ITEM NO. 12 :**

Renewal of AMC of application software

The Member Secretary presented the regular subscription-based software for approval of the BoG. These software is regularly used in the campus. It was requested by the Member Secretary to give their permission for the extension and purchase of AMC of software for next year also.

xiii) **AGENDA ITEM NO. 13:**

Approval for extension of infrastructure for new program AI & ML in next academic session:

The program for infrastructure extension for the next academic session was discussed and approved after deliberations.

xiv) **AGENDA ITEM NO. 14:**

Departmental Budget & Approval for current academic session:

The department budget approval for the current academic session was put up for approval by the BOG. The members discussed and approved the budget.

xv) **AGENDA ITEM NO. 15:**

Corporate Social Responsibility:

Important activities conducted for corporate social responsibility

The Director apprised the members in detail about the various CSR Initiatives launched by the college such as Swachh Bharat Abhiyan, Unnat Bharat Abhiyan, Blood donation camp and Dental camp held during the current year by the institutions.

Celebrations of all important days in a year: A new initiative of celebrating of all the important days in the institute has commenced which is celebrated with the presence of maximum students and faculty and organizing of program which communicate the importance of the day week celebration.

xvi) **AGENDA ITEM NO. 16:**

Sports:

The Director briefed the members that the college has organized the AKTU Zonal Sport Fest on 22nd & 23rd November, 2021. In the event 20 colleges of AKTU of this region has participated. In eight sport events 1107 students of different colleges has participated (Male- 782 & Female- 325) including our students.

Students of our college have proved their mettle not just in academics but in Sports as well by achieving the first position in Basketball (Boys), Kho-Kho (Girls), 4x400 relay (Boys) and 1500m race (Boys & Girls) in this event.

xvii) **AGENDA ITEM NO. 17:**

To consider and approve the reduction in intake in different programs/ courses and addition of new courses

The Director apprised the governing body that due to lack of admissions in certain courses the institute has applied for reduction in intake and the addition of a new course for the session 2021-22, as mentioned below:

- Reduction in Intake
- Reduction in Intake in B. Tech. (Mechanical Engineering) from 120 to 60 Seats
- Reduction in Intake in B. Tech. (Electrical Engineering) from 60 to 30 Seats
- Reduction in Intake in B. Tech. (Civil Engineering) from 60 to 30 Seats
- Addition of new course in B. Tech in AI & ML Engineering 60 seats, against NBA Accreditation of ECE branch.

The reduction in intake of the above courses and the addition of a new program had been approved by the AICTE, New Delhi, and AKTU, Lucknow.

Members of the governing body took note of the facts and discussed the proposal. After detailed discussion, members of the governing body have agreed and accepted the changes in intake unanimously.

Concluding Address by the Chairman:

In his concluding address the Chairman said that focus should be on quality. The quality of education must not be compromised & college should work for creating quality engineers. Start-up by the college students should be given

encouragement even to subsidized Central Space & Technological Support. Further he expressed satisfaction for the positive improvements seen in last one year and appreciated the Governing Board & Advisory Council Members for their contribution and valuable suggestions.

There being no further points, the Director thanked Chairman and other members for sparing their valuable time and for useful deliberations.
