I would like to inform you that my daughter "Himanshi Bhardwaj" is a student at your College (ITS) and I am writing today to lodge a complaint about mis-conduct & inappropriate behavior of one of your staff member's Ms. Shweta.

On 17th May 2022, Ms. Shweta called my daughter regarding some pending fees and started misbehaving & insulting my daughter in front of the entire class which being a teacher is not appropriate. Below are some of the points from her conversation for which I really felt offended: -

My apologies sir but I am really concerned that if the teachers would behave like this with the students, then what would be their future? 
